Terms and Conditions

These Terms and Conditions are related to Samsung Innovation Campus (“**Training**”), a local educational program that equips students with future-proof skills, preparing the next generation with the critical knowledge, competencies and attitudes they need to secure a job in a competitive and technology-driven workplace.

The Training offers a practical education in technologies through online-based courses that can lead to a certification.

The Training course topic is Artificial Intelligence (“**AI**”).

1. Application Date:

The application period for the Training begins at 00:00:01 a.m. Tunisia Time on 1st October 2024 and ends at 11:59:59 p.m. Tunisia Time on 22nd October 2024 (“**Application Period**”). **Please adjust timing of application if not correct**

2. Eligibility:

The Training is only available to the residents in **Tunisia** of ages eighteen (18) years to 29 years old (“**Applicant(s)**”).

Application NOTE: By applying to this Training, The Applicant warrant being at the majority age under Tunisia applicable laws; and have a legal capacity to enter into these Terms and Conditions, and is a resident in Tunisia. The Applicant authorizes to receive communication from Samsung SETN a subsidiary in Tunis (“**Samsung**”), including but not limited to, email, phone, voice mail messaging or by text messaging regarding the Training information.

3. Application Submission:

Applicant may apply for the Training by completing and submitting the official application form (“**Form**”), available on the Samsung website <https://www.sic-samsungtunisia.com/> (“**Application(s)**”) during the Application Period.

Application Form: Upon the completion of the Form from the Applicant, as provided below, the Applicant will be assessed to determine eligibility to the Training. Applicants must comply with the Training prerequisites mentioned in clause 4 below.

The Training participation quota is limited to up to 55 selected Applicants.

Application Description Form: This application form is used to select the right Applicants to enroll to the Training, along with other required test and assignment (if required). The questions will be posted on the Application Form during the Application Period.

All Applications must be received by 11:59:00 p.m. Tunisia Time on 22nd October 2024 in order to be considered. Applications will only be accepted in English and answers to all questions must be in the form of a statement or videos according to the Application form available on the Samsung website through the following link: <https://www.sic-samsungtunisia.com/> The decisions of Applicants' selection pertain to Samsung and is final and legally binding in all matters relating to this Training.

Samsung will enter into correspondence only with the selected Applicants in order to pursue the Training. Samsung reserves the right in its sole discretion to disqualify any Application it determines does not comply with these requirements or these Terms and Conditions, in its sole discretion.

4. Training prerequisites:

Students must have the following prerequisites:

- a. Coding Experience:
 - Prior experiences in learning one of Object-oriented Language (e.g. Java, JavaScript, C++, etc.).
 - A basic level understanding of grammar in Object-oriented Language.
- b. Basic Statistics:
 - Understanding of probability and statistics fundamentals.
 - A proper document certifies candidate's completion of relevant courses should be presented when a candidate submits an application form.

5. Required Learning Environment:

Students must be equipped with their own PCs with the required below specifications:

- Minimum: Windows 8 + CPU i5 + RAM 8GB.
- Recommended: Windows 10 + CPU i7-8700 3.19 GHz + RAM 16GB + NVidia GPU 1660 Ti

6. Training Period:

The Training period will last 8 weeks, the schedule of the Training will be from 1st November 2024 until 27th December (“Training Period”). Samsung will provide access to the selected Applicants (“Student(s)”) to an e-learning platform where Students can access the lectures; read the Training materials; attend pre-recorded sessions with the instructor; take the quizzes and exercises; upload their projects within the Training Period.

7. Assessment:

The scoring assessments of the Students will follow the below criteria:

The Students will be eligible for a certification when both qualifications below are met.

9. Intellectual Property Rights and Attribution:

Samsung owns any Training materials, activity plan, videos and any documents, presentation, content or other materials in connection with the Training, including all copyright and moral rights therein (collectively, the “**Training Materials**”). Students, instructors, speakers, or whomever will be using the Training platform shall not have the right to edit, publish, use, adapt, reproduce, exploit, modify or dispose of any Training Materials and all elements of the Training Materials, online, in print, film, television, or in any other media now or hereafter known throughout the world for any purpose.

As between Samsung and the Student, other than the Training Materials, the Student will retain all of its right, title and interest in and to the Training, the Training idea and any development and implementation of the Training idea into a Capstone Project (collectively, the “**Capstone Project**”), including all intellectual property rights therein. The Student grants Samsung a perpetual, irrevocable, worldwide, royalty-free, and non-exclusive license to use, publicly display and distribute, the Capstone Project as incorporated in the Training Materials for the purposes of using the Training Materials for any purpose, including for administering, advertising, or promoting the Training.

Nothing in these Training Terms and Conditions are intended to restrict Student’s right to market, commercialize, improve, develop, or otherwise pursue the Capstone Project (“**Commercial Activities**”), provided that Student’s pursuit of such Commercial Activities are at Student’s own risk and Student agrees that Samsung is in no way responsible for, and disclaims any and all liability in connection with, any Commercial Activities. Student agrees that it will promptly notify Samsung of any Commercial Activities, and at Samsung’s request will attribute Samsung and the Training as the platform that initially launched the Capstone Project in any materials advertising or promoting the Capstone Project (e.g., on any website, press release, sales documentation or videos for the Capstone Project) (“**Attribution**”), subject to the following paragraph.

Any Attribution, including its content and the manner in which it is presented, shall (a) be at Samsung’s sole discretion, (b) be pre-approved by Samsung in writing, and (c) comply with Samsung’s trademark guidelines. In the event Applicant assigns or otherwise transfers the Capstone Project to any third party, Student shall ensure that such third party is bound by the Attribution obligations herein.

10. Requirements for Capstone Project submission:

Capstone Project submission should not contain, among other things, any content that:

- a) contains trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors) owned by others;
- b) contains any personal identification, such as personal names or e-mail addresses or any third party details;
- c) contains copyrighted materials owned by others (including music, photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media);

- d) contains materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission;
- e) contains look-alikes of celebrities or other public or private figures, living or dead;
- f) communicates messages or images inconsistent with the positive images and/or good will to which the Samsung wishes to associate;
- g) violates any local applicable law in Qatar;
- h) is sexually explicit or suggestive; unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; contains nudity;
- i) promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message;
- j) is obscene or offensive; endorses any form of hate or hate group; appears to duplicate any other video submission; and / or
- k) defames, misrepresents or contains disparaging remarks about other people or companies.

11. Limitation of Liability

Samsung shall not be responsible for: (i) compensating or offering replacements for personal belongings; and (ii) any event of damage and/or injury of any kind that may occur to any of the Students as a result of their participation in the Training.

12. Personal Information

13. Content Consent

Students are not permitted to participate in the Training if they do not get the written permission of their parents or legal guardians if they are considered minor under their local applicable law.

Students must be deemed to give their consent regarding the use of any image shooting, filming and recording pursuant to the Training (“**Content**”). Samsung shall be entitled to the full copyright and usage of the Content and has the right to exploit it as it deems necessary, and at the locations it finds appropriate.
